		Commissioner Dozier reported the following:
		There have been a lot of policy issues going on at the federal level, and we are in the midst of hearings and meetings about the state budget for fiscal year 2026 (effective July 1 <sup>st</sup> ) prior to the May revise and ultimately the June 15 <sup>th</sup> budget bill. Items of note and for consideration for your personal response:
		<ul> <li>Federal</li> <li>Institute of Museum and Library Services (IMLS) – executive order on Mar. 14, 2025, reducing the functions of the IMLS and eliminating many of its non-statuary programs. California receives the most funding (most populated state @ 14% of U.S.) in 2024.</li> <li>E-Rate – a federal initiative through the FCC's Universal Services Fund (USF) which helps K-12 schools and libraries throughout the country access</li> </ul>
		<ul> <li>affordable broadband, and is being heard by the Supreme Court and is at risk.</li> <li>Discounts range from 20-90%, especially crucial for rural, and lower- income areas without universal access</li> <li>In addition to libraries, K-12 schools are given affordable access,</li> </ul>
		<ul> <li>opening the world to all students (54 million+ in US)</li> <li>Access to broadband has become critical in today's world, and as the American Library Association's President Hohl stated: "E-Rate and the other three USF programs are critical to fulfilling ALA's vision of broadband as a human right."</li> </ul>

State (from the California Library Association's Legislative Priorities)

- Restoration of vital library funds which were cut in the previous budget cycle including Restoration of CLSA (California Library Services Act) funding to pre-2024-25 levels.
- Resource sharing amongst libraries, particularly in rural areas where funding challenges negatively impact library access for many patrons.
- Restoration of Lunch at the Library funding to pre-2024-25 levels. Lunch at the Library provides 300,000+ free and nutritious summer lunches, accompanied by literacy-enhanced wrap-around programming for hundreds of libraries each year.
- New funding requests to enhance literacy and learning opportunities for TK-12 grade students, including.
  - One-time funding to ensure library card access for California's schoolaged children
  - Restoration of state-wide access to "BrainFuse" (online tutoring services). Over 600,000 tutoring sessions were utilized during the 2 years BrainFuse was previously available.

Again, Commissioners are urged to voice their concern about these issues by contacting their legislators as private citizens.

The CLA reaffirms their commitment to equitable access to critical library and information services for all. Core values include:

- Libraries as an ongoing community resource, including in times of disaster
- o Broadband equity and digital literacy access for all
- $\circ$   $\,$   $\,$  The freedom to read and access to diverse material
- $\circ$   $\;$  Providing a safe haven for all community members
- Promoting early literacy, school readiness, adult literacy, career development, vocational support, and assistance to vulnerable populations.
- Mandating and funding credentialed Teacher-Librarians in all California Public Schools
- Support for libraries to purchase digital content including eBooks and eAudiobooks at the same price as consumers
- Support for California's law libraries

CLA supports positive action in key areas, including, but not limited to Equity, Inclusion and Anti-Racism, Intellectual Freedom, Privacy and Net Neutrality.
